A. With reference to the Company's final results announcement dated January 13, 2010, the Board proposed to make a
bonus issue of shares (the "Bonus Share Issue") on the basis of one new ordinary share ("Bonus Share") of HK\$0.10,
credited as fully paid, for every one existing share held by the shareholders of the Company whose names are on
the register of members of the Company at the close of business on March 16, 2010.
The Bonus Share Issue is conditional upon the passing of an ordinary resolution by the shareholders of the Company at the
forthcoming annual general meeting (the "AGM") for approving the Bonus Share Issue.
The necessary resolution will be proposed at the forthcoming AGM on March 16, 2010.
Please refer to the Company's final results announcement dated January 13, 2010 for more details of the Bonus Share Issue.
B. The Agreement provides, among other things, that if there is an alteration in the capital structure of the Company during
the Option Period by way of bonus issue, corresponding adjustments shall be made to (a) the number or nominal amount of
the Option Shares then remaining subject to the Option so far as unexercised and/or (b) the Option Price, so as to give the
Advisor or the Nominee(s) the same proportion of the equity capital of the Company as that to which the Advisor or the
Nominee(s) was previously entitled.
Following the Bonus Share Issue, the number of the Option Shares and the Option Price will be adjusted to 73,911,200
shares and HK\$1.13 per Option Share respectively with effect from the first day of dealings in the Bonus Shares so as to
give the Advisor or the Nominee(s) the same proportion of the equity capital of the Company as enlarged by the
Bonus Share Issue.
